TERMS, CONDITIONS, PRIVILEGES OF MEMBERSHIP

ALL APPLICATIONS FOR MEMBERSHIP IN THE DUCK WOODS COUNTRY CLUB, INC., ARE SUBJECT TO THE FOLLOWING TERMS, CONDITIONS, PRIVILEGES, AND RESTRICTIONS:

1. MEMBERSHIP in Duck Woods Country Club, Inc. does not make the member financially responsible for any obligations of the Club. Likewise, membership does not confer upon a member any right, ownership, or interest whatsoever in any property or appurtenances of the Club. Management reserves the right to define conditions of credit limitations and use reasonable means in the collection of accounts, including posting.
2. DISCIPLINARY ACTION may be taken pursuant to the Bylaws, Rules & Regulations against any member for impropriety or violation of rules, regulations, or restrictions.
3. ALL MEMBERSHIP CLASSIFICATIONS may be changed upon approval of the Board of Directors and provided the member pays the difference between the initiation fees. However, initiation fees in full or in part will not be refunded after an application has been approved by the Board of Directors or its designated Committee.
4. THE RIGHT IS RESERVED to change the dues, fees, rules, regulations or charges upon reasonable notice.
5. RESIGNATIONS will be effective at the end of the month during which the request is made.
6. DUES. The amount of dues, fees, costs, expenses to be charged members shall be determined by the Board of Directors and may be modified from time to time upon reasonable notice to the members. Dues may be prepaid annually but otherwise shall be billed monthly. Except as noted in the Initiation Fee Installment, all other dues, fees, costs and expenses due from members shall be due effective as of the statement dates. Upon member's failure to remit payment of any sums due for more than thirty (30) days after any statement date, Duck Woods Country Club, Inc. may declare all amounts to be immediately due and payable including any balance due pursuant to any Initiation Fee Installment Agreement. The Member agrees to pay to the Duck Woods Country Club, Inc. interest on all monies due at the rate of eighteen percent (18%) per annum from the date of default. Members further agrees to pay all costs incurred by the Duck Woods Country Club, Inc. on account of member's default hereunder including, but not limited to, collection costs, court costs and reasonable attorney's fees.

IT IS DISTINCTLY UNDERSTOOD THAT ANY PERSON MAKING APPLICATION FOR MEMBERSHIP IN THE DUCK WOODS COUNTRY CLUB, INC. DOES SO WITH COMPLETE KNOWLEDGE OF THE ABOVE.
